Background

During the FY 22-23 Budget process, the Benbrook Economic Development Corporation (BEDC) held a public hearing and both the BEDC and the Benbrook City Council approved \$518,279 for the beautification of Benbrook Blvd., including the corner project in front of the Russell Feed Store. In 2023, the BEDC also held a public hearing and approved an incentive for 3500 Williams Road for exterior improvements in the amount of \$195,000. Unfortunately, these three projects were not able to be completed during the fiscal year.

FY 23-24 Budget Amendment

In order to complete the three projects, the current approved FY 23-24 BEDC Budget will need to be amended to include the remaining balances of these projects totaling \$469,060.69. This will include carrying over the following amounts to each project budget item as follows:

- Benbrook Blvd. \$281,783
- Russell Feed & Supply \$181,371.39
- 3500 Williams Road \$5,906.30
